Water Restrictions and Penalties:

The CCCSD board of Directors at the December meeting voted to re-instate penalties for going over your usage limits. This is on a month to month basis and will be for the December – January usage. Restrictions are still in place since we are still in a drought.

Thank you again for the welcome and the opportunity to meet with the community group. As mentioned, I will do my best to communicate with you in this newsletter and on the website as well. The District has a small staff to maintain the Water Treatment facility, the Distribution system and all the office activities like billings, payments and your inquiries. ## **Drought Restrictions & Penalties**

Please be aware that penalties are in place for water over usage. The State and Bureau still consider us in a drought. You are allotted 75 % of your 2019 monthly usage **OR** 40 units / HCF whichever is **greater**.

The **Board** reviewed this at the December meeting, and voted to **reinstate the penalties** this month. If you go over your allotment, you will still be notified.

#### \*1 unit / HCF = 748 gallons\*

Reminder of the Penalties schedule:

>100 HCF	\$1,500
50.1 - 100 HCF	\$800
20.1 - 50 HCF	\$600
10.1 - 20 HCF	\$400
5.1 - 10 HCF	\$100
< 5 HCF	\$50

### Meter Reading Dates

You can contact the office to get your meter reading but please give the staff a few days after the meter reading dates to get all reads downloaded and input into the software. You can also read your meter yourself in order to keep track of your usage.
