**Drought Related Forced Conservation – AB 1434:** General Manager Born advised, this is a new bill that is being introduced that imposes even tighter restrictions on people using water by dropping the number down from 55 gallons per person per day to 40 gallons per person per day by the year 2030. Vice Chairman Fust made a motion to send a letter to Lorena Gonzalez who is the Chair of the Assembly Committee on Appropriations. Director Bassham seconded the motion. It was voted on and approved. Full details of this conversation can be seen on the minutes once approved by BOD in the June 2021 BOD Meeting.

**Urgency Item - Start the Process for a New Board Member:** Vice Chairman Fust made a motion to start the process of appointing a new Board member at the June 16th BOD Meeting. # MAJOR DROUGHT \*\*WATER RESTRICTIONS IN AFFECT\*\*

STAGE 4 ~ We MUST CUT BACK NOW!! We have used approximately 25% of our allocation for the year already and we are only 2 months into our allocation of 55% for Domestic & 5% for Ag customers. We know it's scary up here and we all want to keep it green but if we use all of the allotment now, we will be pumping in the summer months from the wells that cannot keep up with demand the way it is now. LET'S ALL DO OUR PART and cut back on our water usage. We as a District cannot afford \$320.00 an acre foot for the water being pumped through the wells during the summer months.

## \*\*Minutes from May 19th, 2021\*\*Next BOD Meeting ~ June 16th 2021\*\*

Blythe, Nora Wilson, Betty, Welch **CALL TO ORDER:** The meeting was called to order at 6:30 PM

**OPEN TIME:** Beverly Fickes, Spokesperson for the Happy Valley Community Committee, advised the Board that the newsletters and minutes should reflect that correspondences from the HVCC are not from her personally but from the Committee as a whole. She also advised that the minutes from February and March were missing the year and a date was incorrect so she requested that those be fixed. Full details of this conversation can be seen on the minutes once approved by BOD in the June 2021 BOD Meeting.

CONSENT/AGENDA: After a discussion about corrections in the April Minutes, Vice Chairman Fust made the motion to approve the April 21st minutes with corrections. It was voted on and unanimously approved. Vice Chairman Fust advised the community, we had a resignation on the Board as some of you may know. Mark Engel had resigned and that opens a space on the Board of Directors. A lengthy discussion was had on adding an urgency item to the agenda in order to start the process of electing a new Board Member at the June 16th BOD Meeting. A motion was made by Vice Chairman fust to add this as an urgency item to the agenda. The motion was seconded by director Bassham, voted on and unanimously approved. Full details of this conversation can be seen on the minutes once approved by BOD in the June 2021 BOD Meeting.

#### **NEW BUSINESS:**

General Manager Retirement: Director Bassham stated, so I just want to say a few things. You will be missed Skip and nobody is going to be able to fill your shoes. It's a happy day for you so congratulations and thank you. Chairwoman agreed and added, for your 30 years of service to this community. General Manager Born thanked Director Bassham and Chairwoman Trenerry. General Manager Born stated, I think it's a good idea to have someone shadow me for a while, for the remaining time that I am here so that I can pass off as much information as possible to make that transition a little bit easier for the person coming into this job or even someone in an interim position for the time just to fill the space if the Board would prefer that. That would probably be a good idea also. Vice Chairman stated, I think Ginger (Director Bassham) mentioned that you might have some people in mind to do that? General Manager Born replied by stating, well yeah, at this point I think it would be a good idea to allow Bill Palmaymesa, the T5 Operator and Cary Brown, the Office Manager to maybe split the duties between them. A long conversation was had discussing the General Manager Born's retirement and his replacement. Full details of this conversation can be seen on the minutes once approved by BOD in the June 2021 BOD Meeting.

Rate Billing – Trinity PUD: General Manager Born advised the Board and the community that Cary had found an issue with our billing software and that the Trinity PUD fee is being billed inconsistently because of these issues. GM Born advised, we still need to do some work, we need to figure out what is going on. We need to talk to the software company to find out if there is a way we can make this work properly but as it is right now, I think we should drop that charge, cancel it, take it out of the equation and find out what is going on. Director Miller agreed. The Board discussed it more and Director Miller made a motion to drop the .12 cent per one hundred cubic feet Trinity PUD fee because of the accounting issue and also because of the possible legal ramifications. Vice Chairman seconded the motion. A lengthy discussion was had and the motion was voted on and it was not passed. Vice Chair asked if he could have this put on the June agenda to have a more detailed description of what is going on. Full details of this conversation can be seen on the minutes once approved by BOD in the June 2021 BOD Meeting.

CAC Rate Proposal: Vice Chairman Fust and Director Miller updated the Board on where the CAC is at with the rate proposal advising that once the rate proposal rational document has been finalized, it will be shown to the public for more input, taken back to legal counsel and then it should be ready to come back to the Board to be reviewed. Director Miller made a motion to have a note from the Board to update the customers on where the CAC is with their proposal put into this newsletter. It was seconded by Vice Chairman Fust. The motion was voted on and unanimously approved. Full details of this conversation can be seen on the minutes once approved by BOD in the June 2021 BOD Meeting. Happy Valley Community Committee Letter to Directors: The Happy Valley Community Committee spokesperson, Scott McVay, read a letter to the Board asking for Chairwoman Trenerry and Director Bassham's immediate resignation from the Board. After a very lengthy discussion Chairwoman Trenerry and Director Bassham both advised that they would not be resigning. Full details of this conversation can be seen on the minutes once approved by BOD in the June 2021 BOD Meeting.

Current Water Usage for 2021: General Manager Born advised that we have already used about 25% of our water allocation already and we may be pumping the wells sooner than we thought. It is going to be VERY costly to pump from the wells and it the wells will not be able to keep up with demand. People have NOT BEEN cutting back on their water usage enough. A long conversation was had and full details of this conversation can be seen on the minutes once approved by BOD in the June 2021 BOD Meeting.
